Subject: Development Plan Review - Lot A-7, Rifle Garfield County Airport

Introduction

The Rifle Garfield County Airport Administration presents the Development Plan for Lot A-7 submitted by Business Aviation Group (BA Group) and Vantage Aviation for BOCC review and approval. The proposed development includes a 26,706-square-foot aircraft storage hangar, an ancillary shop area, and associated infrastructure to accommodate Group II/III aircraft.

This project aligns with the approved Concept Plan and supports the Airport's strategic growth initiatives, enhancing business and general aviation opportunities at RIL.

Key Features of the Development

- Leasehold size 86, 722 sq. ft.
- Estimated Annual Lease Payment \$26,441.19
 - The applicant initially proposed a lease rate of .48/sq. ft. in their approved concept plan with an estimated lease payment of \$41,626.56.
- Hangar Size: 26,706 sq. ft.
- Shop Space: 2,125 sq. ft.
- Ramp Area: 21,688 sq. ft.
- Parking Spaces: 40 (including public-use spaces)
- Lighting: LED fixtures in compliance with airport standards
- Architecture: Design consistent with existing hangars on Lots A-2, A-5, and A-6
- Landscaping: Low-maintenance seeding per airport requirements

Utility Services

- Water/Sewer: City of Rifle (Will Serve Letter issued)
- Electricity: Holy Cross Energy (Will Serve Letter issued)
- Natural Gas: Xcel Energy (Will Serve Letter issued)
- Telecommunications: CenturyLink (Will Serve Letter issued)



Compliance with Airport & County Regulations

- 1. Concept Plan Approval: Approved by the BOCC on January 6, 2025.
- 2. FAA Airspace Determination (7460-1): Submitted and awaiting approval.
- 3. Drainage and Grading Compliance: Phase I Drainage Report submitted.
- 4. Fire Safety Compliance: Review and approval from Colorado River Fire Rescue (CRFR).
- 5. Lease Agreement: The applicant will work with the County to finalize the lease by June 2025.

Economic Impact & Benefits

- Increased Airport Revenue:
 - o Annual Lease Revenue
 - o Additional revenue from fuel sales, landing fees, and other airport services.
- Iob Creation:
 - Construction Phase: Temporary jobs in site development, engineering, and building trades.
 - Operations Phase: Permanent jobs in aircraft maintenance, management, and aviation services.
- Alignment with Airport Growth Strategy:
 - Supports the County's strategic objective to expand general and business aviation services at RIL.

Staff Recommendation

Airport Administration recommends approval of the Development Plan for Lot A-7, contingent upon the following conditions:



- 1. Final Lease Agreement Approval by June 2025.
- 2. FAA 7460-1 Determination Clearance.
- 3. Approval of Fire Safety Plans by CRFR.
- 4. Compliance with Airport Design and Development Standards.

This project presents a significant opportunity to enhance aviation services at RIL while securing a long-term revenue stream for the Airport.
