**SUBJECT:** Fairgrounds Fee Waiver Request for Memorial Day Riders Event.

**SUMMARY:** The Memorial Day Riders are requesting a fee waiver for the use of the Indoor Arena at the Fairgrounds on Sunday May 25 and Monday, May 26, 2025.

**BACKGROUND:** This organization serves the community by raising funds for veterans. All funds go to local veterans in times of need or hardship. They are requesting use of the Indoor Arena at the Fairgrounds for a fundraiser. They used the facility for the same purpose last year and were granted a fee waiver. Staff would need to hard roll part or all the footing surface to allow for tables, chairs, etc.

**DISCUSSION:** The total cost for this event at the "Standard" rate on a county holiday is \$250 per day. A refundable deposit of \$500 is required as well. The BOCC has budgeted \$40,000 for fee waivers at the Fairgrounds for 2025. A total of \$15,200 in fees have been waived so far in 2025.

**RECOMMENDATION:** Approve the request to waive the fees and require the Memorial Day Riders to pay the \$500 deposit, to sign our rental agreement, and to provide the required event insurance certificate.

**ACTION REQUIRED**: Vote on the fee waiver request.
