SUBJECT: Fairgrounds Fee Waiver Request for Flat Tops Church (Rodeo Bible Camp)

**SUMMARY:** Flat Tops Church is requesting a fee waiver for the use of all facilities including 40 stalls for Rodeo Bible Camp on June 16, 17, 18, and 19, 2025.

**BACKGROUND:** Flat Tops Church Rodeo Bible Camp is a annual youth event that is held at the fairgrounds for boys and girls to learn specific rodeo skills or improve skill levels all while hearing Jesus Christ's word. The event range from team roping, barrel racing, pole bending, bull riding, and more.

**DISCUSSION:** The total cost for the Rodeo Bible Camp event at the Youth Rate is \$350.00 per full day, for a total of \$1,400, with a refundable \$500 deposit. The total cost for the stalls at the Night Rate (associated with an event is \$600 (\$15 per stall) per day, totaling \$2,400. The total cost for both rental of facility and stalls is \$3,800. The BOCC has budgeted \$40,000 for fee waivers at the Fairgrounds for 2025. A total of \$15,200 in fees have been waived so far in 2025.

**RECOMMENDATION:** Approve the request to waive the fees and require Flat Tops Church to pay the \$500 deposit, to sign our rental agreement, and to provide the required event insurance certificate.

ACTION REQUIRED: Vote on the fee waiver request.
