SUBJECT: Fairgrounds Fee Waiver Request for Colorado River Valley Chamber of Commerce Chili Cook off.

SUMMARY: The Colorado River Valley Chamber of Commerce is requesting a fee waiver for their 45th Annual Chili Cook Off at the Fairgrounds Indoor Arena on Wednesday October 8th, 2025.

BACKGROUND: The Chamber would like to reserve the Indoor Arena for their event. Staff would need to roll the arena in advance.

DISCUSSION: The cost for this event at the Standard rate on a weekday is \$200 for the Indoor Arena. Chamber is requesting a fee waiver for the rental fee of the Indoor Arena however, the Chamber will pay for the required security. The updated projected total of the BOCC waivers for 2025 is \$15,200 Up to \$40,000 was budgeted for fee waivers this year.

RECOMMENDATION: Approve the fee waiver request. Require the Chamber to sign our event agreement, provide the refundable security deposit, provide the required event insurance certificate and pay for required security for event.
