SUBJECT:

Recommendation and approval to award a contract to PBG Facility Services, LLC for Carpet Installation at the Rifle Garfield County Airport.

SUMMARY:

In accordance with Article 5.2 of the Garfield County Procurement Code ("GCPC"), an Invitation for Bids ("IFB") was posted to the Rocky Mountain E-Purchasing System on June 2, 2025 and advertised in the Post Independent and The Citizen Telegram. This IFB is titled "Carpet Installation" and is solicitation number IFB-GC-AP-01-25. The bid opening was held on June 26, 2025 at 3:00 P.M. At the time of the bid opening two companies submitted bids. Both bids were subsequently reviewed for compliance with the terms and conditions of the IFB, and PBG Facility Services, LLC was found to be the lowest responsive and responsible bidder.

NECESSARY BOARD ACTION:

Discuss and either approve or disapprove the award of a contract to **PBG Facility Services, LLC** in an amount not to exceed **\$69,906.00** for the carpet installation at the Rifle Garfield County Airport and authorize signature of the contract if awarded.
