SUMMARY:

In accordance with Article 3.2.1.c of the Garfield County Procurement Code ("GCPC"), Garfield County can use a cooperative purchase agreement for the procurement of goods and services when such actions serve the best interest of the County. Participation in cooperative procurements as described in this rule are exempt from competitive bidding and advertising requirements.

NECESSARY BOARD ACTION:

Discuss and either approve or disapprove the award of a contract to **Salt Lake Wholesale Sports, Inc** off the **State Price Agreement #177563** in an amount not to exceed **\$32,892.00** for the procurement of training ammo for the Sheriff's Office and authorize signature of the contract if approved.
